Pete drives the big truck in the car park and loves going bush off the beaten track when he gets the opportunity.



Our beloved Sue Ingham who had been with us at Nunyara for about 11 years and almost since our opening day retired at the end of financial year. We believe Sue is spending even more time than ever above the skies of Gawler as an active instructor at the Gawler Flying Club. We had a lovely farewell evening earlier this year and it was great to have Parind and Raj attend who worked with Sue on Tuesdays.



Lisa and Alex have been doing a great job sharing the Admin responsibilities at the rooms and don't complain too much about my late finishes on Monday, Thursday and Friday evenings.
